SUBJECT: LIVESTOCK JUDGING TEAMS SELECTION PROCESS

A Judging Teams Selection Process will be used to select 4-H members to represent Harris County at the District 9 4-H Livestock Judging Contest. Please study this very carefully. Attached is also a list of contests to be held this fall. Please contact them to request rules and entry information.

DISTRICT LIVESTOCK JUDGING TEAM SELECTION PROCESS

1. All 4-H members must compete at the Harris County Fair Livestock Judging contest and at least TWO (2) other contests from the enclosed list.
2. The 4-H Office will combine all three contest scores using a weighted system to select the high point individuals in each age group to represent Harris County at the District Livestock Judging Contest. To reward participation, individuals will receive 1 (one) point for every contest score they submit above the three required.
 - Junior Team - 4 members (Age 8 and in the 3rd grade on 08/31/09)
 - Intermediate Team - 4 members (Age 11-13 on 08/31/09)
 - Senior Team - 4 members (Age 14-18 on 08/31/09)

Only **LEADERS**, not members, turn in scores. All Livestock Judging Scores **MUST** be in the 4-H Office by **MONDAY, MARCH 22, 2010**.
